STERWINS, rated early, angled from the third to sixth path late turn, was hustled into the stretch then rallied willingly and got up just in time under a drive. RAHY'S ATTORNEY was prominent early, took command early backstretch, set a reserved pace, was all out in the stretch but failed to contain the winner at the wire. SOCIETY'S CHAIRMAN rated kindly, moved off the rail late turn, came four-wide into the stretch, launched an all out drive but hung in the late stages. ICE BEAR, rated early, saved ground, closed late turn but had no late response. FRENCH BERET stalked the pace in hand, pulled late backstretch and lapped on the leader briefly, stalked on the turn and chased into the stretch then flattened out. MIKE FOX stalked the pace, angled from the second path to five-wide late turn, was hustled into the stretch but lacked a response and tired. ARTIC CRY pressed the pace in hand, dropped back a bit early turn, raced three-wide, was hustled into the stretch and tired.
