RUTHERIENNE stalked the pace from the inside, was hemmed from late turn to the 3/16 pole, drove through an opening and took command near the furlong marker and moved clear under steady urging. CALLWOOD DANCER (IRE), in touch between horses, was boxed in from upper stretch, did not find racing room until a 16th out then rallied gamely and surged up for the place. MEADOW SAFFRON forced the pace, challenged upper stretch and gained a short lead but failed to hold in the late stages. POINTS OF GRACE stalked four-wide, was set down upper stretch but evened out late. FAVORITE FANTASY, rated off the pace, gained contention five-wide at the top of the stretch but lacked the necessary closing response. TELL IT AS IT IS was unhurried early, angled four-wide late turn, launched an all out drive while widest in the stretch but failed to threaten. REMARKABLE REMY led early, set a pressured pace, was headed upper stretch then gave way grudgingly. ROSES 'N' WINE raced midpack, saved ground but lacked a closing response. SCENERY CHANGE raced off the pace, angled out late turn but lacked a rally.
