By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at the time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% of the added monies to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Grade I or II stakes at a mile or over allowed 2 lbs.; \$60,000 at a mile or over, 4 lbs.; three races at a mile or over other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, MMay 30, 2009 with 19 nominations.

SUCCESSFUL DAN opened clear to set the pace, was collared after a half, met the bid and controlled the tempo through the upper stretch, was headed with a furlong to run, but dug in gamely and came again to prevail narrowly. WARRIOR'S REWARD stalked the pace in hand, drew even leaving the second turn, poked his head in front nearing the furlong marker, battled determinedly but grudgingly gave way in the final strides. OMNISCIENT attended the pace along the inside, angled out entering the stretch but failed to improve his position. DUMAR was unhurried into stride, got through to make a belated gain but failed to threaten. GRESHAM settled in hand four wide but lacked a response when called upon. BROAD STONE showed little.
