1¹/₁₆ MILES. (1.392) 92ND RUNNING OF THE DWYER. Grade II. Purse \$200,000 FOR THREE YEAR OLDS. No nomination fee. \$2,000 to pass the entry box. All starters to receive a \$1,500 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Any horse that competes in both the Woody Stephens and Dwyer will have their entry fee waived for the Dwyer. Weight 123 lbs. Non-winners of \$200,000 at a mile or over in 2009 allowed 2 lbs. \$60,000 at a mile or over in 2009 or \$40,000 twice in 2009, 4 lbs.; \$50,000; or \$30,000 twice at a mile or over, 6 lbs. (Maiden, claiming, starter, restricted or restricted stake races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, June 20, 2009 with 26 Nominations.

KENSEI tucked in behind the early leaders while saving ground, settled in good position for a half, moved out to launch his bid leaving the far turn, split rivals to challenge at the five-sixteenths pole, took charge leaving the quarter pole, quickly opened a clear advantage in midstretch and edged away under intermittent right hand urging. CONVOCATION was taken in hand soon after the start, raced well back for a half, worked his way forward while moving out midway on the turn, swung five wide at the top of the stretch then closed late in the middle of the track to clearly best the others. WARRIOR'S REWARD stumbled badly at the start, raced far back for six furlongs, gained along the rail at the quarter pole, drifted out under left hand whipping in upper stretch and rallied belatedly in the middle of the track. AMERICAN DANCE pressed the pace three wide for a half, raced just outside the winner while beginning to drop back on the turn and steadily tired thereafter. MASALA chased four wide along the backstretch, angled in while within striking distance on the turn, advanced three wide into the stretch and steadily tired thereafter. JUST BEN rushed up to gain the early advantage, set the pace on the rail for six furlongs then gave way in upper stretch. SUNDAY SUNRISE was in hand early and failed to mount a serious rally.
