RAHY'S ATTORNEY stalked the pacesetter from the rail, closed gradually late backstretch, took command inside FRENCH BERET early turn, turned that one back after a short rebuttal, widened leaving the turn then held under a drive. MARCHFIELD, unhurried to the far turn, angled off the rail closing late turn, rallied three-wide and was gaining steadily to the end. CHAMPS ELYSEES (GB), well back early along the second path, closed four-wide into the stretch, launched an all out drive but evened out in the late stages. CATCH THE LUCK was unhurried early, angled from two-wide to four-wide late turn, chased into the stretch and finished gamely in vain. SPICE ROUTE (GB) was well back early, angled out closing late on the final turn, came six-wide into the stretch and never reached contention. FRENCH BERET led quickly, set a reserved pace and enjoyed a clear lead on the backstretch, was headed from the inside early on the far turn, dug in and challenged the new leaders, was unable to match strides, chased to the stretch and tired.
