VENTURA raced off the pace in hand, angled out late turn, charged to the lead approaching the final furlong and finished best still under a coaxing hand ride. FERNELEY (IRE) raced midpack, saved ground, angled out late turn, rallied inside the winner but was outfinished. STERWINS settled of the pace, angled out late turn and rallied from well back. JUNGLE WAVE stalked the pace, forced the issue three-wide on the turn, dueled into the stretch, led briefly but was passed and weakened. BRIBON (FR), in touch between horses, launched an all out drive in the stretch but evened out late. FIELD COMMISSION raced midpack between rivals, chased into the stretch and raced determinedly to the end. RAHY'S ATTORNEY stalked the pace, forced the issue between foes on the turn then gave way in the final furlong. SAND COVE stalked the pace, closed along the rail late turn and chased gamely to the end. GRAND ADVENTURE set a pressured pace, was engaged late turn, held a short lead at the top of the stretch but yielded with a furlong still on tap. DAYLIGHT EXPRESS raced midpack, angled from the third path to five-wide late turn then lacked a rally.
