CORINTHIAN stalked the pace three wide, rallied to catch FIRST SAMURAI at the top of the stretch, came in to put that rival in tight just inside the eighth pole, then drifted out inside the sixteenth pole forcing FIRST SAMURAI out into FLASHY BULL and prevailed. FIRST SAMURAI quickly moved to the fore, made the pace along the rail, responded when challenged by CORINTHIAN at the top of the stretch, steadied and angled outside that rival when put in close inside the eighth pole, then just saved the place after being forced out in deep stretch. FLASHY BULL chased the pace, was outmoved in early stretch but was coming on again when bothered inside the sixteenth pole and just missed the place. MY GOLDEN SONG chased the pace along the rail, was outmoved into the stretch, angled out and was gaining on the top ones late. REHOBOTH rated off the pace, steadied along in traffic on the backstretch, angled out for the stretch run and closed with a belated rally. CAN'T BEAT IT reserved early, made a run three wide on the far turn to reach contention, then tired. JAZIL failed to menace. HEMINGWAY'S KEY saved ground and never threatened. ITSALLBOUTTHECHASE unhurried early, raced three wide on the far turn and faltered. GREAT POINT checked in traffic on the first turn and was never a factor. Following a stewards inquiry and a claim of foul by the rider of FIRST SAMURAI, CORINTHIAN was disqualified and placed third for interference to that rival and FLASHY BULL in the stretch run.
