LAWYER RON prompted the early leader while reserved and well out in the strip, dueled the middle half, showed the way by a larger margin into the stretch, asked for some run when straightened for home, kicked strongly clear. MARK OF SUCCESS showed the way into the first turn, briefly clear onto the backstretch, raced on even terms with the winner inside that one into the far turn, proved no match for that same foe in the drive, remained clear for the place. HYTE REGENCY settled toward the rail, moved a bit closer late in the second turn, lacked a further response in the drive. MALAMEEZE within striking distance in the three path, came up empty for the drive. SAINT AUGUSTUS raced four wide most of the way, also lacked a late response. MIDWAY MAN trailed, no threat. RED BORDEAUX forwardly placed, bobbled, pulled up in distress into the far turn.
