Supplementary nominations may be made at the time of entry Thursday, February 2, 2006 by payment of \$2,500 each (includes all fees). \$40,000 Guaranteed plus \$10,000 KTDF for KTDF eligibles only. WARRIOR WITHIN vied for the early lead out in the four path, angled in a bit before a half, raced with MALAMEEZE wide three wide and inside that one, took over after six furlongs and drew off under steady urging. MALAMEEZE five wide early when forcing the pace outside the winner, pressured that one thereafter but was no match in the drive. FINAL COPY seven wide into the first turn when within striking distance, stayed well out in the strip on the backstretch, advanced six wide to a forward position on the second turn but tired in the drive. READILY six wide into the first turn, was in a bit tight approaching the backstretch, recovered, was blocked when attempting to rally into the second turn, angled out five wide midway through that turn with three furlongs to go but had no late bid. TEMPORARY SAINT five wide into the first turn when within striking distance, angled in to be off the rail on the second turn and tired. DOMESTIC OIL six wide early, prompted the pace outside, held on well to the three furlong marker and tired. I'M WAITING FOR U forwardly placed three wide, moved to the inside once in the second turn and gave way. TEMPLAR'S CUP close up early off the inside, stopped.
