LIMEHOUSE reserved racing along the inside, eased out and rallied to catch DEPUTY STORM at the sixteenth pole, then drew clear. DEPUTY STORM set the pace along the inside to the sixteenth pole, then couldn't stay with the winner while holding the place. SARATOGA COUNTY hit the gate at the start, then checked soon after, saved ground around the turn, swung wide for the stretch run and closed well to be up for the show. WYNN DOT COMMA tracked the pace, lacked room leaving the turn, angled out and had no late response. WEIGELIA failed to menace after breaking slowly. BLUSHING INDIAN unhurried early, raced five wide on the turn and was not a factor. BOURBON N BLUES off slowly, chased the pace three wide around the turn and tired. HARBOUR GATE chased the pacesetter into the stretch and faltered. GHOST MOUNTAIN up close early, raced four wide on the turn and faded. BACHELOR BLUES was through early.
