WYNN DOT COMMA taken in hand to track the pace, eased outside the leaders in the stretch, rallied under pressure to take over at the sixteenth pole and edged away. SARATOGA COUNTY chased the pace three wide, was floated out by SMOKUME at the top of the stretch, then continued on with good courage to be up for the place while being outfinished by the winner. GHOST MOUNTAIN tracked the pace along the inside, came around the tiring FORTUNATE BUY on the turn, rallied along the rail to reach near even terms for command in midstretch, then gave way in the final sixteenth. SMOKUME chased the pace, moved to gain a slim lead on the turn, then drifted out at the top of the stretch, was straightened away, maintained a slim advantage to the sixteenth pole and weakened. EXCELLENT BAND was no factor after being outrun early. FORTUNATE BUY broke to the inside at the start, showed speed along the inside to past midway of the turn and faltered. HEART OF JULES raced four wide on the turn and faded.
