5 FURLONGS. (Turf) (.53³) ROAR S. Purse \$95,000 (includes \$20,000 FTBOA – FL TB Owner Brdr Assoc Fund) THREE YEAR OLDS. Free nomination by Sunday, May 5. \$750 to enter. A \$100 supplemental nomination fee may be made at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers \$20,000 to the owners of a registered Florida-bred divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 123 lbs. Non-winners of a stakes race allowed 3 lbs.; two races other than maiden, claiming, or starter, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings. In the event this race is taken off the turf it will be run on the Tapeta course at the same distance. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 52 feet).

CRIMSON ADVOCATE bobbled at the start, was prompted along while in range from the two path, inched closer to the pacesetter along the inside rounding the turn, swung from the four path into the lane, and drew past the inner pacesetter around the sixteenth. REEF RUNNER rated in the three path, was coaxed into the turn, floated out to the six path at the entering the stretch, and ran on while on his left lead for place. SIR FLASH raced off the pace in the three path, tipped to the rail rounding the turn, was cued passing the quarter but got immediately stymied turning into the lane, tipped outwards into the final furlong, and kept on for show. OKIRO chased inside, steadied going into the turn, tipped out to the four path at the top of the stretch, and mildly stayed on. ESPERON went clear to set the pace in the two path, tipped to the rail going into the turn, was roused entering the stretch, but yielded around the sixteenth. LIGHTING CLOUDS bumped with an inner foe at the start, trailed in the five path and never threatened. SNOWNAME bumped with an outer foe at the start, tracked in the four path, but drifted way outside leaving the turn, and continued trying to drift out in the stretch while being eased.
