FULMINEO stalked the pace outside horses down the backstretch, circled the far turn four wide, gained command in upper stretch and drew off under steady handling. CRYSTAL QUEST hugged the inner rail down the backstretch, waited forroom approaching the turn, remained al ong the rail, checked in tight quar ters entering the stretch, eased off the rail and rallied gamely inside foes. ABRUMAR, steadied when bearing out at the start, raced in the two path betw een horses leaving the backstr etch and on thefar turn, stea di ed in close quar ter s approaching the stretch, angled outside and rallied on his left lead. MASSIF lacked speed, stayed along the inner rail the first turn, moved up a bit on the far turn, sw ung to the five path in upper stretch and passed tired horses. ECHO LANE, stea died when bear ing in leaving the starting gate, was kept outsidehorses thr oughout, floated to the seven path in upper stretch and was no factor. SPEEDYNESS, clear soon after the start, set the pace near the inner rail and gave way in mid stretch. NAPTOWN raced near the inner rail on both turns and weakened thr ough the stretch. TOCAYO came out at the break, prom pted the pace outside SPEEDYNESS and faltered. BUCKIN' DREAMER, outside horses down thebackstretch, chased the pace and faltered entering the stretch.
