6 FURLONGS. (1.071) GOLDEN CIRCLE S. Purse \$50,000 **FOR THREE-YEAR-OLDS.** Weight: 124 lbs. Non-winners of \$60,000 in 2023-2024 allowed 2 lbs.; non-winners of \$45,000 in 2023-2024 allowed 4 lbs.; \$30,000 in 2023-2024 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. **SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START.** Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then highest lifetime earnings. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees.

MR FILLIP was forwardly placed racing just off the leader up the backstretch, moved up to engage DESPERATE MAN entering the turn, shook free turning for home, quickly widened to a commanding lead, stayed sharp with willing response and pulled away to an easy score. RUN FIRE RUN raced in range two wide between rivals just off the top flight, hustled along into the upper stretch, sustained a steady bid, was no match for pulling away winner but sustained response and captured place. DESPERATE MAN was quickly clear from the outside, angled inside and led the way, came under pressure then vied for the lead with MR FILLIP around the turn, could not match strides turning for home and weakened to show. FIRESPIITTEN KITTEN raced in close contention along the inside up the backstretch, remained in close range and launched a bid near the quarter pole, was no match for pulling away winner but sustained bid into upper stretch then flattened in the final furlong. SIROTTORaced in contention positioned four deep in a bunched up field, hustled along in range around the turn then gave way. POWER SLAM was not far from the frontend while racing three wide between foes in the opening quarter, weakened then got pulled up while injured late on the turn and vanned off.
