FREEDOM PRINCIPLE raced off the early pace two wide, circled five wide around the far turn, surged outside and was up in the final strides. IN A JAM bumped with TIME SON Gat the start, raced off the early pace two wide, a dvanced three wide between foes around the far turn, took the lead in upper stretch and led until the final strides. PLEASE ADVISE saved ground off the pace, went three wide between foes around the far turn, angled back the rail in upper stretch, rallied, tipped out late and was up for the show while appearing to try to lugin late. PREVENT set the pace along the rail, battled on past the eighth pole and was outfinished. SAL VATTORE PRINCE steadied entering the first turn, saved ground in midpack, made some progress three wide around the far turn but was one-paced through the lane. DANCING GROOM raced well back two wide, steadied near the quarter pole, swung six wide in upper stretch and was no threat. EHSAANtrailed inside, swung widest in upper stretch and passed tiring rivals. TIME SONG bumped at the start, had early speed between foes, rated back angled in early on the first turn, raced up close inside and faded in the lane. BRAWN chased the pace two and three wide and came up empty in the lane. SENTENZA pressed the pace two wide and retreated through the stretch.
