PAYNE lacked speed, dropped to the inside to save ground through the turn, improved upper stretch, no match for the top two, clear of the others. MAHOMEY off a step slow, four wide out of the turn, went evenly through the lane to finish up evenly. PERFECT DUDE four wide when evenly paced through the turn, also lacked a closing rally. RUGGS flashed brief speed along the inside, faltered in the turn. EDGE TO EDGE vied up front while inside the winner and between foes, backed up as well.
